
PREFACE

The findings of the report indicates that more females (60.6%) than males (39.4%) were seen at eye Out-Patient facilities. The figure further shows that female's attendance was higher than males in all age groups. The general pattern shows that there was low attendances in younger ages (under 10 years) and older ages (75+ years). There is no much variations in ages 10 -74 with proportion ranging from 4.6 percent to 6.0 percent of all attendances. The lowest number of attendances were among under ones for both males and females.

This report covers the period from April to September 2022. In April 2022, Sir Seretse Khama International Airport (SSKIA) received the highest total rainfall in a month at 225.5 mm followed by Jwaneng at 186.9 mm and Goodhope at 154.3 mm. Over the six months period, the wettest area was SSKIA,



recording a total of 236.5 mm followed by Jwaneng at 219.6 mm and Goodhope at 191.1 mm.







In November 2023, Botswana's total export earnings declined by 24.3 percent, dropping from the revised October 2023 figure of P3, 871.7 million to P2, 929.8 million.

The Employed population (15 years and above) recorded an increase between Q4 2022 and Q3 of 2023, from 717,725 to 788,616 persons, an increase of 9.9 percent. This was accompanied by an increase of 12.5 percent of unemployed persons, from 244,594 to 275,159 persons over the period. The youth labour force increased by 10.5 percent between Q4 2022 and Q3 of 2023, from 471,139 to 520,582.

The youth unemployment rate rose by 0.9 percentage points, increasing from 33.5% to 34.4%. Meanwhile, the overall unemployment rate for individuals aged 15 and older grew by 0.5 percentage points, moving from 25.4% in Q4 of 2022 to 25.9% in Q3 of 2023.

n 2022, the total road network in Botswana measured 32,564.8 km. Of this length, 18,507 km (56.8 percent) was under the care of the Central Government while 14,057.8 km (43.2 percent) was managed by Local Authorities. Road density in Botswana was 0.06 km sq. There were 601,081 licensed vehicles in Botswana in 2022, a decrease of 2.1 percent from 613,845 licensed vehicles in 2021. Out of this total, privately owned vehicles accounted for 97.9 percent of the total while government fleet constituted only 2.1 percent. An increase of 73.3 percent was realised in aircraft movements recorded in 2022, from 36,878 in 2021 to 63,911 aircraft movements. Domestic aircraft movements made up 78.9 percent of the total while international movements constituted 21.1 percent. A total of 652,141 air transport passengers were carried in 2022, 54.0 percent were international while 46.0 percent were domestic.



During Q3 2023, a total of 10,876 motor vehicles were registered for the first time, of which 74.7 percent were passenger cars. Used vehicles made up 78.3 percent of the vehicles registered for the first time, while 21.6 percent being brand new vehicles and 0.1 percent being re-built vehicles. Goods transported through rail increased by 3.1 percent in Q3 2023 from 273,537 tonnes transported in Q2 2023 to 282,001 tonnes. A total of P65.9 million in revenue was generated, which was an increase of 34.0 percent from P49.2 million realised in Q2 2023.





The number of deaths registered increased from 12,219 in 2020 to 17,590 in 2021, a 43.4 percent increase. The sex ratio at death remained stable at 104 in 2021. The crude death rate increased from 5.2 in 2020 to 7.3 in 2021. The number of marriages increased from 6,518 in 2020 to 7,631 in 2021, an increase of 17.1 percent, the highest ever experienced. About 0.4 percent of the brides required consent from parents or guardians as they were aged below 21 years. A total of 58,073 births (live and stillbirths) were registered in 2021, out of which about 13 percent were occurrences from the previous years. From the total registered, 51,823 were current occurrences of which 861 were stillbirths.



AGENDA 2063 -THE AFRICA WE NEED

ooking at the decade-long economic trajectory of the Agenda 2063 First Ten-Year Implementation Plan (FTYIP), it is observed that real GDP increased from P72271.7 to P80963.1, while unemployment also increased from 18.6% to 25.6%. These two indicators imply a positive correlation, which contrasts with the predictions of economic theory, particularly Okun's Law. According to Okun's Law, a rise in GDP is generally expected to lead to a reduction in the unemployment rate (Cuaresma, 2003. According to Okun's Law, an increase in GDP should typically result in a decline in the unemployment rate, Cuaresma, (2003). Therefore, the performance rating of the priority area for the income, jobs, and decent work priority area shows a decline. This underscores a need for reassessment and potential adjustment of strategies to address the discrepancy and achieve the intended goals of the Agenda 2063 FTYIP.

The Index of Mining Production stood at 101.8 during the fourth quarter of 2023 compared to 97.3 registered in the same quarter of the previous year, showing a year-on-year growth of 4.6 percent. The main contributor to the increase in mining production were Diamonds at 5.3 percentage points, as shown in Table 2. Copper in Concentrates and Coal were the main negative contributors to mining production, at negative 0.8 and negative 0.2 of a percentage point respectively.



GPP at constant 2016 prices for the fourth quarter of 2023 was P50, 265.1 million compared to the revised P50, 729.5 million recorded in the third quarter of 2023, a decrease of 0.9 percent (See table 3). The real Gross Domestic Product increased by 1.9 percent during the period under review, as opposed to an increase of 5.5 percent in the same quarter of 2022. The growth was attributed to real value added for Mining & Quarrying, Real Estate and Public Administration & Defence industries which rose by 6.4, 6.3 and 5.9 percent respectively. All other industries recorded positive growths of more than 0.1 percent except Diamond Traders and Water & Electricity which contracted by 85.4 and 27.9 percent respectively



total of 2, 359,609 persons were enumerated in the 2022 Population and Housing Census comprising of 1,150,615 males (48.8%) and 1,208,994 females (51.2%). This yields a national sex ratio of 95 males for every 100 females. All of the decennial censuses prior to 2022 indicated higher counts of females than males, which is a similar trend observed in the current Population and Housing Census. However, a different trend is observed in some of the districts, particularly in the mining towns (see Table 3). This change may well be accounted for by the changing population composition in the working ages attributed in particular to labor, which is mainly male-dominated (in the construction industry in particular).

PRIMARY SCHOOL **STATS BRIEF 2018**

he results presented in this stats brief indicates that the total enrolment in all primary schools was estimated at 366,253 in 2018. Government schools enrolled 93.1 percent of the pupils while only 6.9 percent were enrolled in private schools. There has been an increase of 2 percent on enrolment between 2017 and 2018 from 359,193 to 366,253. Regions which enrolled high proportions of pupils were Central region accounting 124,546 pupils followed by Kweneng region with 52,185 pupils and Southern region with 45,107 pupils.



The poverty rate is predicted to have increased to 17.0 percent in Q4 of 2019, reduced to 16.7 percent in Q4 of 2020 and hiked to 18.0 percent in 2021 Q4 following which a reduction to 14.5 percent was predicted. The 18.0 percent in 2021 Q4 may be due to economic shocks that were experienced by households at the peak of Covid-19 pandemic in the country, while the decrease to 14.5 percent in 2022 may indicate improvements in economic conditions or the effectiveness of interventions in reducing poverty, offering hope for continued progress in poverty alleviation efforts.



The Mining Producer Price Index moved from 111.5 in Quarter 3 of 2023 to 135.0 in Quarter 4 of 2023, registering an increase of 21.1 percent. The increase was due to a rise in all section indices except the Gold section index, which registered a decrease of 0.7 percent and the quarry section index, which remained unchanged between the two periods.

There was a stable movement of prices in 2023 as opposed to 2022, as most of the groups registered a slight change on the annual average inflation rates. However, the Transport group registered a significant drop of 26.9 percentage points from 31.1 percent recorded in 2022 to 4.2 percent in 2023.




SECONDARY SCHOOLS STATS BRIEF 2022

The report shows that there has been an increase of 4.2 percent in the number of secondary schools, from 283 in 2012 to 295 in 2022. An increase of 22.7 percent was recorded in the number of privately owned secondary schools between 2012 and 2022, whereas Government schools increased by only 0.9 percent, no changes were recorded in Government Aided Secondary Schools. However, between 2015 and 2021 number of privately owned schools reduced by 3.8 percent. An increase of 8.0 percent in private schools was again recorded between 2021 and 2022. Out of the 295 secondary schools that operated in 2022, Government schools constituted 80.3 percent, while government aided and private schools constituted 1.4 and 18.3 percent respectively.

he nominal Gross Domestic Product for the first quarter of 2024 was P64, 631.7 million, up from P61, 787.8 million in the previous quarter, indicating a quarterly increase of 4.6 percent in nominal terms. During this period, Public Administration and Defense contributed the most to GDP at 17.4 percent, followed by Mining & Quarrying at 12.5 percent. Real GDP for the first quarter of 2024 decreased by 5.3 percent compared to the positive 5.3 percent growth registered in the same quarter of the previous year.



The main contributors to the 2022 average annual inflation rate were; Transport (7.2 percentage points), Food & Non-Alcoholic Beverages (1.6 percentage points), Housing, Water, Electricity, Gas & Other Fuels (1.2) percentage points) and Miscellaneous Goods & Services (0.8 of a percentage point). The notable increase in inflation was primarily driven by a substantial rise in Transport, which increased from 2.8 percentage points in 2021 to 7.2 percentage points in 2022, recording a rise of 4.4 percentage points. 



The number of marriages increased from 5,333 in 2013 to 5,642 in 2022. Nonetheless, there was a notable rise in the number of marriages, from 6,518 in 2020 to 7,631 in 2021. This sudden increase followed the easing of travel and gathering restrictions that had been put in place to stop the then rampant spread of COVID19. 2020 saw the suspension of most civil and national registration services, including marriage solemnization, as a result of the nation's lockdown and travel restrictions. Deferred marriage intentions that had already been published resulted in a backlog of marriages that were eventually formally sealed in 2021. Following the COVID-19 pandemic, marriages fell by 26.1% in 2022 compared to 2021. However, this decline is not a cause for alarm as things were beginning to return to normal.



The Employed population (15 years and above) recorded a decrease between Q3 2023 and Q1 of 2024, from 788,616 to 754,147 persons, a decrease of 4.4 percent. This was accompanied by an increase of 4.3 percent of unemployed persons, from 275,159 to 287,059 persons over the period. Formal sector employment increased from 490,861 in Q3 of 2023 to 504,738 in Q1 of 2024, an increase of 2.8 percent. The youth labour force decreased by 2.1 percent between Q3 2023 and Q1 of 2024, from 520,582 to 509,683. otswana's total imports were valued at P 97, 140.3 million in 2024. Food imports contributed P 14, 698.6 million, representing 15.1 percent of total imports during the year. Cereals accounted for 18.9 percent of food imports while Beverages, Spirits & Vinegar and Preparations of Vegetables, Fruit, Nuts or Other Parts of Plants followed with 17.2 percent and 8.7 percent respectively.

n 2024, Total Imports were valued at P97, 140.3 million, having increased by 10.1 percent (P8, 946.2 million) from the P88, 194.1 million recorded in 2023. The upsurge was primarily influenced by increases in diamonds, Machinery & Electrical Equipment and Vehicle & Transport Equipment. Diamond and Machinery & Electrical Equipment imports rising by 33.1 percent (P4, 380.8 million) and 16.9 percent (P2, 076.8 million) respectively. Vehicle & Transport Equipment imports appreciated by 20.3 percent (P1, 328.7 million) from the value of P6, 549.5 million in 2023.

Total Exports in 2024 shrank by 21.3 percent (P16, 580.4 million), decreasing from P77, 899.1 million in 2023 to P61, 318.6 million in 2024. The decline was primarily driven by significant decreases in the exports of diamonds and Gold. Diamonds saw a decrease of 32.0 percent (P19, 742.8 million), falling from P61,689.7 million in 2023 to P41,946.9 million in 2024 while Gold experienced an even sharper drop of 89.4 percent (P255.8 million), declining from P286.3 million in 2023 to just P30.5 million in 2024.

Trade deficit was recorded in 2024, with imports rising while exports experienced a decline.
