

## **BOTSWANA FOOD IMPORTS**

## December 2023

Potswana's total imports were valued at P6, 421.5 million during the month of December 2023. In this amount, food imports contributed 15.8 percent. Beverages, Spirits & Vinegar and Cereals accounted for 22.6 percent and 14.4 percent of food imports respectively. Preparations of vegetables, fruit, nuts or other parts of plants followed with 8.9 percent.

Among Beverages, Spirits & Vinegar, the most imported commodity was Waters, including mineral waters and aerated waters, containing added sugar or other sweetening matter or flavored, accounting for 27.6 percent. Beer made from malt contributed 23.9 percent.


Other Maize (corn) and Semi-milled or wholly milled rice, whether polished or not or glazed made contributions of 41.0 percent and 26.2 percent each, to the cereal chapter.
