BOTSWANA FOOD IMPORTS February 2022

As at February 2022, Botswana's total imports were valued at P 8, 270, 089, 856.1. In this amount, food imports contributed P 860, 997, 431.8 translating to 10.4 percent. Beverages, Spirits & Vinegar accounted for 18.9 percent of food imports, followed by Cereals and Preparations of cereals, flour, starch or milk; pastry cooks' products with 18.0 percent and 8.8 percent respectively.

Fermented Beverages (e.g. cider, Perry, mead, sake) and Beer made from malt were the most imported among Beverages, Spirits & Vinegar, during February 2022, accounting for 33.1 percent and 20.9 percent respectively. Waters; including mineral and aerated, containing added sugar or other sweetening matter or flavored followed with 17.1 percent.

With regard to Cereals, the most imported types were maize (corn), other than seed accounting for 33.9 percent. Wheat and muslin, other than durum wheat or seed, and Grain sorghum, other than seed, followed with contributions of 30.8 percent and 19.5 percent respectively.


