

Botswana Food & Beverage Imports

April 2026

Botswana received imports worth **P8, 219.3 million** in April 2026. In this amount, Food & Beverages imports amounted to **P912.2 million**, representing 11.1 percent of total imports. The leading imported chapters among Food & Beverages imports, were Cereals (Chapter 10) and Beverages, Spirits & Vinegar (Chapter 22) with contribution of 15.6 percent and 13.6 percent, respectively.

Cereals emerged as the most prominent commodity imported during the period under review. Within this commodity group, the leading imported products were Other maize (corn) (HS100590), Other wheat, other than durum wheat (HS100199), and Semi-milled or wholly milled rice, whether or not polished or glazed (HS100630). These products accounted for 48.9 percent, 25.2 percent, and 24.4 percent of total cereal imports, respectively, highlighting the country's strong reliance on staple grain imports to meet domestic demand

Beverages, Spirits & Vinegar was the second dominant commodity imported. The major imports of food products among this sector are Beer made from malt (HS220300) and Other fermented beverages, (for example, cider, perry, mead, sake), mixtures of fermented beverages & mixtures of fermented beverages & non-alcoholic beverage (HS220600) with contributions of 33.0 percent and 17.2 percent. Other waters (HS220299) followed with a contribution of 18.0 percent.

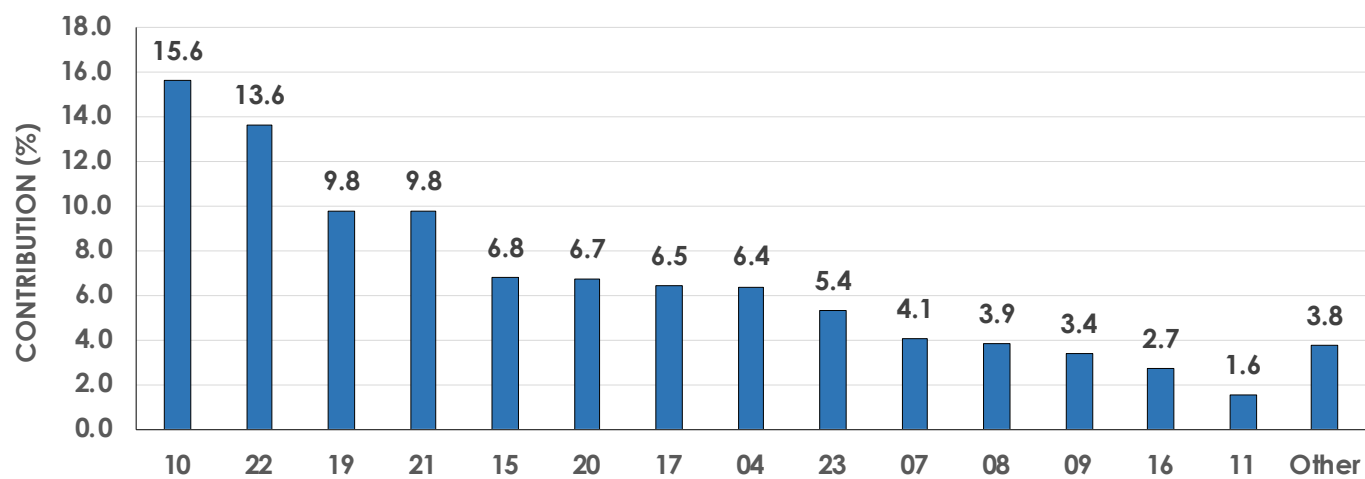
