BOTSWANA FOOD & BEVERAGES IMPORTS

January 2025

n January, Botswana's total imports were valued at P6, 653.2 million. In this amount, food & beverages imports amounted to P1, 092.9 million, representing 16.4 percent of total imports. Beverages, Spirits & Vinegar (Chapter 22) and Cereals (Chapter 10) accounted for 20.2 percent and 17.1 percent of Food & Beverages imports in that order. Sugars and sugar confectionery (Chapter 17) followed with a contribution of 9.3 percent.

Beverages, spirits and vinegar was the most prominent commodity imported. The most imported types of Beverages, spirits and vinegar were Beer made from malt: accounting for 37.0 percent followed by Other fermented beverages (for example, cider, perry, mead, sake), mixtures of fermented beverages and mixtures of fermented beverages & non-alcoholic beverages, not elsewhere specified or included with a contribution of 24.3 percent. Other waters, including mineral waters and aerated, containing added sugar or flavoured & non -alcoholic beverages (excluding fruit,nut or vegetable juices) followed with a contribution of 16.2 percent.

Cereals was the second dominant commodity imported. Other Maize (corn) and Other grain Sorghum made contributions of 44.9 percent and 23.9 percent to chapter 10 respectively.


