WORK PERMITS HOLDERS – FIRST QUARTER 2023

This stats brief presents a summary on characteristics of expatriates who held valid work permits as at the end of March 2023.

i.

The brief is produced through a collaborative process with the Department of Labour and Social Security who issue work permits. Copies of the approved work permits are forwarded to Statistics Botswana for capture and analysis.

Information on work permit holders gives an indication of the posts which are occupied by foreigners for monitoring progress in localization. Presentation of statistics on work permit holders by occupation and industry gives an indication of jobs currently held by non-citizens which informs on the skills and sectors where expatriate recruitment continues to be needed. The information is also useful to researchers, planners and policy makers in the country.

The results presented in this brief show an increase in work permit holders from 3,850 in December 2022 to 4,851 in March 2023 an increase of 26.0 percent. The Agricultural sector continues to record the majority of work permit holders with 24.7 percent followed by Education with 18.0 percent. Work permit holders by age group showed that overall, the majority of work permit holders fell in the age group 40-44 years at 16.7 percent, followed by age groups 45-49 and 35-39 recording 16.0 percent and 14.8 percent respectfully.

1.0 INTRODUCTION

Work permits represent an authorization issued by the Department of Labour and Social Security allowing nationals of other countries to work legally in the country. Entries on the permit shows the reasons for issuing the permits. The main reasons for issuing such permits are employment, education, family, and other reasons. The analysis of permits in this brief is confined only to work permits, drawn from National administrative registers and databases.

The Department of Labour and Social Security issues work-permits, and copies of such issued work-permits are forwarded to Statistics Botswana to be analysed. Although all work permit forms received by Statistics Botswana for a specific quarter are processed and captured into the data base, others arrive after the publication of the stats brief, and are thus captured for analysis for the subsequent publication(s).

The profile of work permit holders at country level reflects the specific skills which may be in short supply among the nationals. In addition, it may show the prevailing economic and employment opportunities which attract foreigners into the country.

Six graphical presentations are given; **Figures 1 & 2** presents work permit holders by Nationality, **Figures 3 & 4** depicting work permit holders by industry and occupation respectively. **Figures 5 & 6** illustrate the trend of total work permit holders and employee work permit holders respectively. More detailed information is presented in the tables.

2.0 TOTAL WORK PERMIT HOLDERS


Table 1.1a provides information on the total number of work permit holders. There were 4,851 valid work permit holders as at end of March 2023. Among the work permit holders, Employed persons accounted for 74.8 percent (3,627), while Self-employed persons accounted for 25.2 percent (1,224). Overall, there were more male than female permit holders, at 70.7 percent and 29.3 percent, respectively (See **Table 1.1a**).


Employee work permit holders consist of those holding new work permits and those whose work permits have been renewed. As presented in Table 1.4a, there were 2,671 new employee work permit holders, compared with 956 who held renewed permits. In both categories, males constituted a higher proportion of work permit holders. For the fourth quarter of 2022, there were 2,212 new employee work permit holders and 753 renewed permits.

For the new work permit holders, out of the 2,671 (73.6 percent), males accounted for 1,912 (71.6 percent) and 759 (28.4 percent) were females. In the renewed category, out of the 26.4 percent (956), males accounted for 16.6 percent (601) and females 9.8 percent (355), respectively, of the total employee work permit holders.

Table 1.7 shows quarterly work permits holders by industry and sex from the second quarter of 2022 to the first quarter of 2023. The data shows an increase over the period. Between June 2022 and September 2022, total work permit holders decreased by 121 persons, from 3,801 in June 2022 to 3,680 in September 2022, a decrease of 3.2 percent. However the total work permits increased by 170 persons from 3,680 in September 2022 to 3,850 in December 2022, an increase of 4.6 percent. Total work permits further increased by 1,001 persons from 3,850 in December 2022 to 4,851 in March 2023, an increase of 26.0 percent.

Figure 1 and **Table 1.1b** shows that Zimbabwean nationals continues to have the highest proportion of work permits compared to other countries' nationals, accounting for 45.3 percent (2,197), followed by Other African countries at 12.7 percent (615).






3.0 WORK PERMIT HOLDERS BY AGE GROUP

The age distribution of work permit holders showed that the highest number was recorded in the 40-44 age group at 16.7 percent, followed by the 45-49 and 35-39 year age groups recording 16.0 and 14.8 percent respectively. For the Self –employed category, age group 40-44 and 45-49 had the largest share with 183 permit holders each (15.0 percent) followed by the 50-54 age group with 181 permit holders (13.3 percent). In the Employee work permit holder's category, the 40-44 age group stood at 629 permit holders (17.3 percent) followed by the age group 45-49 with 591 permit holders (16.3 percent), see Table 1.2a & 1.2b. There were 1,108 work permit holders in the youth age group (15-35) which accounted for 22.8 percent of the total work permit holders.


4.0 WORK PERMIT HOLDERS BY INDUSTRY

Table 1.3a and **Figure 3** present the distribution of Employee and Self Employee work permit holders by Industry. The highest proportion of work permit holders were registered for Agriculture with 24.7 percent, followed by Education at 18.0 percent and Wholesale & Retail Trade with 9.9 percent. Agriculture also recorded the highest proportion of Employee work permit holders category with 30.7 percent, followed by Education with 23.4 percent. For the Self-employed work permit holders category, Wholesale and & Retail Trade was above other industries, recording 31.6 percent of work permit holders, followed by Manufacturing and Construction industries at 13.5 percent and 13.0 percent respectively.



5.0 WORK PERMIT HOLDERS BY OCCUPATION

Employee Work permit holders (New and Renewed) by occupation is shown in **Table 1.4a**, **1.4b** and **Figure 4**. The tables show that Elementary Occupations recorded the highest proportion of work permit holders at 30.0 percent (1,089) followed by Professionals with 1,083 persons (29.9). Furthermore, the majority of new permit holders were recorded in the Elementary occupations category, accounting for about 36.2 percent (967 persons) of all new work permit holders, followed by professionals with 26.4 percent (704).




6.0 EMPLOYEE WORK PERMIT HOLDERS BY TRAINING

The distribution of employee work permit holders by training and sex is presented in **Table 1.5a** and **1.5b**. It can be observed from the tables that the proportion of employee work permit holders who had "No training" accounted for 43.5 percent (1, 577) of all employee work permits, followed by Degree holders at 35.4 percent (1,283 persons). Diploma holders accounted for 15.3 percent (556 persons). Certificate holders contributed 5.8 percent (211 persons) of employee work permit holders.

Table 1.6a & **1.6b** shows that, the largest number of employee work permit holders were trained for Education programs at 455 persons (12.5 percent) followed by those trained for Medicine and Health related programs with 309 persons (8.5 percent). Business & Administration program as well as Engineering Trade programs followed with 5.7 and 4.5 percent respectively. Veterinary Programs as well as Environmental Protection Programs both recorded the lowest share of 0.03 percent and 0.1 percent respectively.

7.0 TREND OF TOTAL WORK PERMIT HOLDERS


Table 1.8 and **figure 5** below show trends in work permit holders from the year 2017 to 2023. There was a significant decrease in work permit holders between the year 2017 and 2021, from 5,766 to 3,409 representing a decrease of 40.0 percent. Between the year 2021 and 2023 the number of work permit holders increased from 3,409 to 4,851, an increase of 42.3 percent.

8. TREND OF EMPLOYEE WORK PERMIT HOLDERS

Table 1.9 & **Figure 6** below shows trend in total employee work permit holders from the year 2017 to 2023. The trend shows that between the year 2017 and 2021 there was a significant decrease in employee work permit holders, from 5,045 to 2,754, a decrease of 45.4 percent. Between the year 2021 and 2023, the number of work permit holders increased from 2,754 to 3,627, an upsurge of 31.7 percent, while between the years 2017 and 2023 the number of work permit holders declined from 5,045 in 2017 to 3,627 in 2023, a decrease of 28.1 percent.
