## Preface

This International Merchandise Trade Statistics (IMTS) Monthly Digest presents statistics on Botswana's total imports and exports of goods as at the end of June 2014. Data for imports and exports of goods is currently complete up to June 2014.

Since Statistics Botswana receives new data on monthly basis, and there is continuous data editing as various tables and reports are produced, the database is therefore updated from time to time. As a result of editing and revision of data, figures on previous Monthly Digests (for subsequent months) and that on the current Monthly Digest may differ.

This monthly digest presents summaries of Total Merchandise Trade from the first quarter of 2009 to June 2014 as presented on **Table 1**. Trade by Principal Commodity groups is presented on **Tables 2.1** for imports and **Table 2.2** for exports, giving data from the first quarter of 2009 to the month under review. **Table 2.3** gives trade on diamonds only. Direction of trade is given for the most recent twelve months and this appears on **Tables 3.1** and **3.2** for imports and exports respectively.

Three graphical presentations appear in this digest. **Chart 1** shows imports, total exports and trade balance from January 2008 to June 2014 while **Charts 2.1** and **2.2** shows Principal Commodity groups for major imports and major exports respectively, for June 2014 only.

In the current digest, data for June 2014 have been added to the disaggregation process, meaning that diamonds imports for January 2013 up to June 2014 are those that were only imported into Botswana for processing (polishing and cutting), and excludes those coming in for aggregation leading to re-export. Exports for these months comprise exports of Botswana diamonds plus exports from diamond processing companies operating in Botswana. Disaggregated data from July 2012 to December 2012, is still unobtainable, however efforts are still being made to get the necessary information.

Statistics on commodities that were mostly traded during the most recent two months, in this case May 2014 and June 2014, appear on **Tables 4.1 (A) & (B)** for imports while exports are presented on **Tables 4.2 (A) & (B)**. Trade at Chapter Level (2 digits Harmonized Commodity Description & Coding System) appears on Table 5, presenting data for May 2014 and June 2014.

 Table 1 distinguishes domestic exports from re-exports while other tables give total exports, which is the sum of the two.

We sincerely thank all stakeholders involved in the formulation of this monthly digest, their continued support and feedback, as we strive to better serve Batswana and all other important users of our services.

# **11.0 TOTAL TRADE**

Total merchandise trade as presented in this section refers to imports, domestic exports and re-exports as well as trade balance.

# 1.0.1 Data Revision

It should be noted that IMTS is compiled using date of recording of trade as opposed to date of assessment of goods by customs. This means that as goods cross the border, trade is recorded and this is the reference month for compilation of IMTS. Some of these goods may however be held by customs for some time pending final assessment for tax or duty purposes.

If final assessment is done two or three months, or even more, after goods had crossed the border, the affected trade will then update trade for the particular month when the goods crossed the border, therefore it does not form part of trade for the month during which final assessment was done. This is mostly common with imports. Revised Data for the month preceding the one under review will normally be high as compared to the other months due to more goods (from the previous month) being released after final assessment. At times incorporation of data from manual border posts also adds to the difference.

Discussions on Sub-Sections 1.1 to 1.3 are based on Table 1.

## 1.1 Imports

Discussions on imports are based on cost, freight and insurance (CIF) value. June 2014 total imports were valued at P3, 656.4 million, showing a decrease of 11.8 percent (P491.3 million) from the revised May 2014 value of P4, 147.6 million. When annualizing total import figures, June 2014 imports value decreased by 8.4 percent (P337.1 million) from the June 2013 value of P3, 993.5 million.


# 1.2 Total Exports

In June 2014 total exports were valued at P6, 655.0 million, an increase of 27.7 percent (P1, 442.2 million) from the May 2014 revised value of P5, 212.8 million. Comparison of June 2014 total exports value to that of June 2013 (P2, 943.6 million) shows an increase of more than 100 percent.

## 1.3 Trade Balance

June 2014 recorded a trade surplus of P2, 998.7 million.

**Chart 1** shows trade surplus in June 2014. It should be noted that trade balance is largely dependent on the value of diamonds traded as these are associated with high values.

## 2.0 TRADE BY PRINCIPAL COMMODITIES

Principal commodity groups refer to selections of related commodities grouped together to form major groups. Commodities forming a group may be of related chapters, for example; "Machinery & Electrical Equipment" which combines machines and electrical appliances; "Vehicles & Transport Equipment" which combines vehicles and other equipment used for transport purposes.

In some cases it becomes challenging to come up with further groups of related chapters or commodities. This occurs when commodity groupings' contributions to the total, are minimal. In such cases, the commodities are grouped together under the general category called "Other".

## 2.1 Principal Imports

Imports by Principal Commodity Groups together with the associated percentage distributions, appear on **Table 2.1**, covering the first quarter of 2009 to June 2014. Percentage distributions are however only shown for totals of years 2011 to 2013, as well as for months of May and June 2014. **Chart 2.1**, however gives graphical presentation of Principal Import Commodity groups for June 2014 only.

Composition of imports by principal commodities for June 2014, shows that Fuel contributed the highest to total imports (P3, 656.4 million) with 21.7 percent (P795.0 million), followed by Machinery & Electrical Equipment with 15.9 percent (P579.6 million) and Vehicles & Transport Equipment with 12.8 percent (P468.3 million). Food, Beverages & Tobacco, Chemicals & Rubber Products and Metals & Metal Products contributed 12.0 percent (P438.4 million), 11.9 percent (P435.5 million) and 6.6 percent (P239.8 million) respectively.




Chart 2.1: Principal Imports Composition – June 2014

Note: Other Goods include all Other Goods not elsewhere specified as in Table 2.1 Based on data from automated borders only


# 2.2 Principal Exports

June 2014 total exports were valued at P6, 655.0 million, with 85.8 percent (P5, 708.5 million) attributed to exports of Diamonds. The diamond trade is for both rough and polished diamonds and **Table 2.3** gives trade in diamonds at commodity level from the first Quarter of 2009 to June 2014. However, it should be noted that diamond exports for January 2013 to June 2014 are for rough diamonds originating from Botswana plus those from diamonds processing companies only. Re-exports of diamonds from aggregation process are not included in the January 2013 to June 2014 data.

Copper/Nickel contributed 6.0 percent (P401.8 million) to total exports during June 2014. Machinery & Electrical Equipment and Meat & Meat Products contributed 1.8 percent each with P123.1 million and P120.0 million respectively to total exports during the month under review.

Percentage distributions for major export groups can be observed on **Table 2.2** while **Chart 2.2** gives the graphical presentation for June 2014 only. Total exports discussed here are the sum of domestic exports and re-exports.

## **3.0 TRADE BY REGIONAL AND MAJOR PARTNERS**

Direction of trade gives imports by source while exports are presented by last known destination. Only major trading partners are considered individually, while smaller trading partners are grouped together under a general category. Data for the most recent twelve months appear on **Table 3.1** for imports and **Table 3.2** for exports.

## 3.1 Imports by Region and Major Trading Partners

Imports for June 2014 were valued at P3, 656.4 million, with 84.0 percent (P3, 071.0 million) and 1.2 percent (P43, 4 million) coming from South Africa. In the period under review, imports from Asia were valued at P255.1 million, representing 7.0 percent of total imports. Among the Asian countries, Israel and China contributed 2.2 percent (P78.8 million) and 1.9 percent (P71.3 million) respectively during the month under review.

The European Union (EU) supplied imports valued at P145.2 million, representing 4.0 percent of total imports during June 2014. Imports from the EU were mainly from Belgium with a contribution of 1.8 percent (P66.3 million) of total imports during the month under review. Imports from the United States of America (USA) were valued at P87.9 million, representing 2.4 percent of total imports during June 2014.

Imports at regional and country level (for selected countries) are presented on **Table 3.1**; however, percentage distributions do not form part of this table.

# 3.2 Exports by Region and Major Partner Countries

Total exports for June 2014 were valued at P6, 655.0 million, with 43.6 percent (P2, 900.9 million) destined to Asia. India received most of exports destined to Asia at 18.0 percent, representing P1, 194.6 million of total exports. During the same month, Israel received 10.1 percent (P671.3 million), the United Arab Emirates (UAE) 5.4 percent (P358.1 million), Singapore 4.5 percent (P298.2 million), Hong Kong 3.2 percent (P214.4 million) and Vietnam received 1.0 percent (P69.8 million) of total exports.

Exports destined to the EU were valued at P2, 324.3 million, representing 34.9 percent of total exports during the period under review. Belgium and Finland received 32.0 percent (P2, 131.2 million) and 1.4 percent (P92.5 million) respectively, while the United Kingdom got 1.1 percent (P70.0 million) of total exports during the month under review.

South Africa, Namibia and Zimbabwe received 8.7 percent (P579.8 million), 2.0 percent (P134.2 million) and 1.0 percent (P67.8 million) respectively, of total exports during the month under review.

Exports to Norway were valued at P207.0 million, representing 3.1 percent of total exports (P6, 655.0 million) during June 2014, while the USA and Switzerland received 3.0 percent (P200.1 million) and 2.3 percent (P150.7 million) respectively.

Other destinations for exports can be observed on **Table 3.2**; however, percentage distributions do not form part of the table

## **5.0 TECHNICAL NOTES**

IMTS are compiled by International Merchandise Trade Statistics Section of Statistics Botswana. External trade statistics here refers to trade in goods only. International Service Trade Statistics (ISTS) are not compiled by this unit. The primary source of External Trade data is Customs & Excise Division which is part of Botswana Unified Revenue Service (BURS). Customs & Excise Division is responsible for data capture for both computerized and manual borders and the monthly raw data files are transferred to Statistics Botswana for data processing, in electronic form.

Up to April 2009 Monthly Digest, Botswana was practicing Relaxed Special Trade Type. The Relaxed Special Trade Type takes in to account goods that are exported or imported for inward or outward customs processing while the Strict Special Trade Type does not include the same.

In June 2009, the Botswana External Trade database was revised to cater for General Trade Type as per the United Nations Statistics Division recommendations. The General Trade Type gives a complete coverage of External Trade as compared to the Special Trade Type.

Imports are valued CIF (cost, insurance & freight) while exports are valued FOB (free on board). The value of imports includes transport and insurance costs to the importing country. Exports value consists only of the value of goods as they leave the exporting country. Goods are valued as at the time they cross the border of the exporting country.

## 5.1 Definitions used

**Domestic Exports:** Goods of Botswana origin being exported permanently out of Botswana for consumption in the outside world.

**Re-Exports:** Goods that were initially imported for local consumption and are now being exported permanently out of the country or goods which were exported in the same condition as imported or after undergoing minor transformation which leaves them not substantially changed.

Imports: Goods imported from the outside world, into Botswana, for local consumption.

**Trade Balance (Net Export):** This refers to the total value of goods exported minus the total value of goods imported by a given economy in a given period of time. A positive trade balance (trade surplus) indicates that a country is exporting more in value terms than it is importing. A negative trade balance (trade deficit) indicates that the country importing more than it is exporting.
