Preface

International Merchandise Trade Statistics play a vital role in many economies, Botswana included. It is an account of all transactions of goods between a country and the rest of the world. The account measures the value and quantity of goods which add to or subtract from the stock of material resources of a country, by entering (imports) or leaving (exports) its economic territory. Therefore, trade statistics remains one of the major indicators of the performance of a country's economy and its competitiveness in the world market.

The monthly International Merchandise Trade Statistics are used extensively in the compilation of national accounts and balance of payments. Furthermore, these statistics are also used by government institutions and other stakeholders for trade negotiations and other various purposes.

This International Merchandise Trade Statistics (IMTS) monthly digest presents statistics on Botswana's total imports and exports of goods during September 2020. It shows summaries of total international merchandise trade as presented in Table 1.0. Trade by principal commodity groups is presented in Table 2.1 for imports, and Table 2.2 for exports, while Table 2.3 gives trade on diamonds only. The direction of trade appears in Table 3.1A (imports) and Table 3.2A (total exports). Major trading partner countries by commodity groups, as a percentage of trade at the region or country level, for September 2020 are presented in Table 3.1B for imports and Table 3.2B for exports. Table 4.1A presents statistics on commodities which were mostly imported during September 2020, while exports are given in Table 4.1B.

Changes in data for the corresponding months when comparing the current digest and the previous ones may be attributed to data from transactions which had deferred customs duty assessments. The data for such transactions would only be available at a later stage after customs duty assessments had been completed.

Executive Summary

This International Merchandise Trade Statistics (IMTS) monthly digest provides trade statistics on Botswana's total imports and exports of goods during September 2020.

Botswana's overall exports amounted to P6, 831.8 million, a rise of more than 100 percent (P3, 650.2 million) compared to the revised August 2020 value of P3, 181.6 million. Imports stood at P8, 037.9 million, displaying an increase of 39.5 percent from the revised August 2020 value of P5, 761.0 million.

During the period under review, Botswana's exports were mostly absorbed by Asia with a market share of 54.7 percent. The United Arab Emirates (UAE) and India received exports representing 26.4 percent and 22.2 percent of Botswana's exports respectively, during the month under review. Exports to India were mainly attributable to Diamonds, while all exports to the UAE were Diamonds. Belgium received 27.5 percent of total exports during the month, all attributable to Diamonds.

South Africa was the major source of imports into Botswana with a contribution of 46.7 percent to the country's total imports. The UAE and Belgium contributed 21.3 percent and 14.8 percent respectively, to total imports during the period under review.

With regard to regional groupings, SACU was the major source of imports with a contribution of 48.6 percent. Asia and the EU accounted for 33.0 percent and 16.6 percent respectively.

The leading Import commodity groups were Diamonds followed by Food, Beverages & Tobacco with contributions of 47.9 percent and 11.3 percent.

During the current period, exports transported by Air accounted for 94.5 percent of total exports while those by Road and Rail represented 5.4 percent and 0.2 percent respectively. Imports by Road Transport accounted for 44.0 percent whereas those entering by Air and Rail represented 34.4 percent and 21.6 percent, respectively.

1.0 Total Trade

Total merchandise trade refers to imports, domestic exports, re-exports and trade balance. Discussions are based on September 2020, which is also referred to as the reference period, the period under review or the current month, throughout the digest.

1.1 Data Revision

Statistics for previous monthly digests, contain preliminary figures which are subsequently revised when new information becomes available. Revisions are made on a monthly basis, when monthly data files are uploaded into the database with additional information of previous months. In some instances, revisions are negligible while in other cases they are significant.

Transactions for July and August had late customs duty assessments which were finalised during September 2020, hence the need to show data revision. **Table A** shows revised data for the affected months, comparing figures as at the August 2020 Digest and the current.

There has been a 19.6 percent (P521.6 million) upward revision of total exports for the month of August, as displayed in **Table A**. This is largely attributable to revised records of exports of Diamonds which rose by P480.3 million (22.6 percent), from P2, 124.2 million to P2, 604.5 million. On the other hand, Imports for August 2020 increased minimally by 1.4 percent (P78.0 million) from P5, 683.0 million to a revised figure of P5, 761.0 million.

1.2 Imports

Imports are valued at Cost, Insurance & Freight (CIF), which includes the cost of the commodity, insurance and freight charges, but excludes customs or any other duties paid on arrival. During September 2020, total imports were valued at P8, 037.9 million, an increase of 39.5 percent (P2, 276.9 million) compared to the revised August 2020 import figure of P5, 761.0 million. The increase in Diamonds imports of over 100 percent (P2, 114.1 million) had a significant contribution to the overall increase in total imports.


1.3 Total Exports

During September 2020, Botswana's export earnings went up by over 100 percent (P3, 650.2 million) from the revised value of P3, 181.6 million, recorded for August 2020 to P6, 831.8 million in September 2020. The increase is mostly attributed to the rise in the exports of Diamonds from P2, 604.5 million to P6, 356.1 million.

1.4 Trade Balance

During September 2020, Botswana recorded a trade deficit of P1, 206.1 million.

2.0 Trade By Principal Commodity Groups

Principal commodity groups refer to selections of related commodities grouped together to form major groups. Commodities forming a group may be of related chapters or commodities, for example 'Vehicles & Transport Equipment' which combines vehicles and other equipment used for transport purposes.

In cases where it becomes a challenge to come up with further groups of related chapters or commodities, the commodities are grouped together under the general category called 'Other'. This occurs when a commodity group's contribution to the total is minimal.

2.1 Principal Imports

During September 2020, Botswana received total imports amounting to P8, 037.9 million. Diamonds contributed the most to total imports at 47.9 percent (P3, 848.5 million), followed by Food, Beverages & Tobacco with 11.3 percent (P908.1 million). Contributions made by other commodity groups are illustrated in Table 2.1 and Chart 2.1.





Chart 2.1: Composition of Principal Imports- September 2020

2.2 Principal Exports

Botswana's total exports for September 2020 were valued at P6, 831.8 million, with 93.0 percent (P6, 356.1 million) attributed to Diamonds, while Machinery & Electrical Equipment accounted for 2.5 percent (P172.8 million). Contribution made by other commodity groups are illustrated in **Table 2.2** and **Chart 2.2**.

3.0 Direction Of Trade

The direction of Trade analyses the value of merchandise trade between Botswana and her major trading partners. Thus the direction of trade discusses the last known destination for exports and sources of imports. Only major trading partners are considered individually, while smaller trading partners are grouped together under a general category. Trade by major trading partner countries, regions and principal commodity groups for imports and exports, during September 2020 appears in Table 3.1A and Table 3.2A, respectively. Table 3.1B (imports) and Table 3.2B (exports) show percentage distributions for major sources and destinations by principal commodity groups during the same month.

3.1 Imports by Major Trading Partner Countries and Regions

Botswana imported P8, 037.9 million worth of goods from the globe in September 2020. SACU supplied 48.6 percent (P3, 906.7 million) of Botswana's total imports during the current period. The top most imported commodity group from the SACU region was Food, Beverages & Tobacco, with a contribution of 22.3 percent (P869.5 million) of total imports from the region. Fuel, Chemicals & Rubber Products and Machinery & Electrical Equipment followed with contributions of 15.5 percent (P607.5 million), 13.4 percent (P521.7 million) and 12.9 percent (P505.8 million), respectively (Refer to Table 3.1B).


In September 2020, imports from South Africa represented 46.7 percent (P3, 751.8 million) of total imports. Food, Beverages & Tobacco contributed 22.6 percent (P849.7 million) while Fuel, Machinery & Electrical Equipment and Chemicals & Rubber Products contributed 14.0 percent (P525.0 million), 13.4 percent (P503.3 million) and 13.3 percent (P500.7 million), of total imports from the country, respectively (refer to **Table 3.1A** and **Table 3.1B**).

Imports from Namibia represented 1.4 percent (P108.7 million) of total imports during the month under review, with 75.8 percent (P82.4 million) of that total attributable to Fuel imports.

The Asia block supplied P2, 650.4 million, representing 33.0 percent of total imports into Botswana in September 2020. The major commodity groups imported from the regional block were Diamonds, Chemicals & Rubber Products and Vehicles & Transport Equipment with contributions of 88.4 percent (P2,343.3 million), 3.7 percent (P97.1 million) and 3.3 percent (P88.0 million) respectively, of total imports from the region.

The UAE, Singapore and India were the chief sources of imports from Asia having supplied imports representing 21.3 percent (P1, 708.1 million), 4.4 percent (P352.8 million) and 2.2 percent (P 174.2 million) of total imports, respectively.

Botswana received imports worth P1, 337.2 million from the EU, accounting for 16.6 percent of total imports in September 2020. The major commodity groups imported from the EU were Diamonds and Machinery & Electrical Equipment, accounting for 88.9 percent (P1, 188.2 million) and 6.5 percent (P86.6 million) respectively, of imports from the union. Belgium was the major source of imports from the EU, at 14.8 percent (P1, 189.9 million) of total imports during the period under review.





3.2 Exports by Major Trading Partner Countries and Regions

Belgium, UAE and India were the major destinations for exports from Botswana during September 2020, having received 27.5 percent (P1, 881.7 million), 26.4 percent (P1, 800.7 million) and 22.2 percent (P1, 512.6 million) of total exports respectively. Diamonds contributed almost 100 percent for exports to India, while for the other two countries the contribution of the same commodity group to total export was 100 percent (refer to **Table 3.2A** and **Table 3.2B**).

South Africa received 12.4 percent (P846.2 million), attributable to Diamonds and Machinery & Electrical Equipment at 59.1 percent (P500.3 million) and 15.3 percent (P129.7 million) of total exports to the country.

Other destinations for exports can be observed in tables 3.2 A and 3.2 B.




Chart 3.2: Exports by Major Trading Partner Countries – September 2020

4.0 Imports and Exports by Top imported and Exported Commodities

During this period of the Covid-19 pandemic whereby the economic situation is still uncertain, it is essential to present the most traded goods with a view to guiding users as to what commodities could be produced in the country for import substitution or possible exportation. The top traded commodities for both flows are presented in Table 4.1A for imports and Table 4.1B for exports.

5.0 Imports and Exports by Mode of Transport

For the purposes of compilation of International Merchandise Trade Statistics, mode of transport refers to the method of transport used for the carriage of goods in and out of the country. These statistics are predominantly collected to be used as guidance in formulating transport policy and monitoring international transport routes, as transport is critical for trade facilitation. The modes of transport that are mainly used in Botswana for international merchandise trade are Air, Road and Rail. **Table B** presents statistics relating to modes of transport while **Chart B** gives the graphical illustration.

Total imports amounting to P3, 539.6 million, representing 44.0 percent, were transported into the country by Road. Transportation of imports by Air and Rail accounted for 34.4 percent (P2, 765.3 million) and 21.6 percent (P 1,732.2 million) respectively.

During the period under review, 94.5 percent (P6, 452.8 million) of total exports were transported by Air, while Road transport accounted for 5.4 percent (P 368.3 million).




Chart B: Imports and Total Exports by Mode of Transport – September 2020

7.0 Concepts, Sources and Methods

IMTS are compiled by the International Merchandise Trade Statistics Section of Statistics Botswana, and uses the General Trade system. International Merchandise Trade refers to external trade in goods only. International Service Trade Statistics (ISTS) are however not compiled by this section. The primary source of international merchandise trade data is the Customs & Excise Division at the Botswana Unified Revenue Service (BURS). The Customs & Excise Division is responsible for data capture for both computerised and manual borders, and the monthly raw data files are transferred to Statistics Botswana for data processing.

Imports are valued CIF (cost, insurance & freight), while exports are valued FOB (free on board). The value of imports includes transport and insurance costs to the importing country. The Exports value consists only of the value of goods as they leave the exporting country.

7.1 Time of Recording of Trade

IMTS is compiled using date of recording of trade as opposed to date of assessment of goods by customs. This means that as goods cross the border, trade is recorded and this is the reference month for compilation of IMTS. Some of these goods may however be held by customs for some time pending final assessment for tax or duty purposes.

If the final assessment is done later, for example two or three months, or even more, after the goods had crossed the border, the affected trade will then update trade for the particular month when the goods crossed the border, therefore it does not form part of trade for the month during which the final assessment was done. This is mostly common with imports. Revision of data for the month preceding the one under review will normally show high values as compared to revisions for other months due to more goods (from the previous month) being released after final assessment.

7.2 Concepts and Definitions

- i. Domestic Exports: These are goods originating from the compiling country, being permanently exported out of the country for consumption in the outside world. This includes products from customs inwards processing; for example, if a country imports wheat, processes the wheat into bread flour and exports the bread flour and bye products from the milling process, these will all leave the country as domestic exports.
- ii. Re Exports: These are exports of foreign goods that were initially recorded as imports into the compiling country. These goods are exported in the same state that they came in except for wear and tear. An example will be re-exportation of a motor vehicle that was initially imported into the compiling country and after being used it is now being exported to a foreign country.
- iii. Total exports: This is the sum of domestic exports and re-exports
- iv. Imports: These are goods imported from the outside world, into the compiling country, for local consumption. This includes re-importation of locally produced goods that were initially exported and are now being imported back into the country.
- v. Trade Balance (Net Export): This refers to the total value of goods exported minus the total value of goods imported by a given economy in a given period of time. A positive trade balance (trade surplus) indicates that a country is exporting more in value terms than it is importing. A negative trade balance (trade deficit) indicates that the country is importing more than it is exporting.

7.3 Exclusions from IMTS

- i. Goods in Transit This is trade that is simply passing through the compiling country solely for the purpose of being transported to another country.
- **ii. Goods temporarily admitted or dispatched -** These are goods that, at the time of admission/dispatch, are intended to stay in the receiving country temporarily and that after their stay they will be returned in the same state. These goods include display equipment for trade fairs and exhibitions, commercial samples, means of transport, containers, equipment for working, etc.
- iii. Monetary Gold- This is gold to which the monetary authorities have title and is held as reserve assets.
- iv. Issued banknotes and securities and coins in circulation-These goods represent evidence of financial claims and are excluded from IMTS

The above list of exclusions from IMTS is, however, not exhaustive and only a few that are common, simple, straightforward and easy to understand have been picked as examples.
