March 2024

otswana's total imports were valued at **P 6**, **991.0 million** during the month of March 2024. In this amount, food and beverages imports amounted to P 1, 099.2 million, representing 15.7 percent of total imports. Cereals (Chapter 10) and Beverages, Spirits & Vinegar (Chapter 22) accounted for 23.8 percent and 15.2 percent of Food & Beverages imports respectively. Preparations of vegetables, fruit, nuts or other parts of plants (Chapter 20) followed with a contribution of 8.7 percent.

Among Cereals imports, the most prominent commodity was Other Wheat and muslin, not Durum Wheat- other than seed accounting for 36.6 percent followed by Other maize (corn) with a contribution of 26.3 percent.


Beer made from malt and Other fermented beverages (Cider, Perry, mead, sake), mixtures of fermented beverages and mixtures of fermented beverages & non-alcoholic beverages not elsewhere specified made contributions of 32.8 percent and 24.6 percent respectively to chapter 22.
