

n February, Botswana's total imports were valued at **P6, 658.8 million**. In this amount, food and beverages imports amounted to P1, 235.8 million, representing 18.6 percent of total imports. Beverages, Spirits & Vinegar (Chapter 22) and Cereals (Chapter 10) accounted for 20.6 percent and 19.6 percent of Food & Beverages imports in that order. Sugars & sugar confectionery (Chapter 17) followed with a contribution of 7.7 percent.

Beverages, spirits & vinegar was the most prominent commodity imported. The most imported types of within the Chapter was Beer made from malt: accounting for 36.1 percent, followed by Other fermented beverages (for example, cider, perry, mead, sake), mixtures of fermented beverages & mixtures of fermented beverages, with a contribution of 22.8 percent. Other waters, including mineral waters & aerated, containing added sugar or flavoured & non -alcoholic beverages (excluding fruit, nut or vegetable juices) followed with a contribution of 16.4 percent.

Cereals were the second dominant commodity imported. Other Maize (corn) and Other grain Sorghum accounted for the largest shares at 44.7 percent and 21.0 percent to chapter 10 respectively. Semi-milled or wholly milled rice, whether or not polished or glazed followed with a contribution of 17.7 percent.


