PREFACE

This Stats Brief provides a preliminary overview of international visitors to the country in 2023. The comprehensive Tourism Statistics Annual Report will give detailed information on total arrivals and departures, including tourist arrivals for the entire year. Notably, this report provides the first complete year statistics when all Botswana border posts were operational after the resumption of normal activities following the COVID-19 pandemic.

The statistics contained therein includes tourist arrivals by country of residence and other key characteristics. These statistics are compiled from electronic and manual embarkation records completed at gazetted points of entry into the country and cover all ports of entry as well as airports.

In 2023, Botswana received 1,183,432 international visitors (tourists). Most of these visitors were from the SADC sub-region. South Africa contributed 394,090 tourists, accounting for 43.0 percent of the total tourists from SADC countries. Detailed list of tourists by country of residence can be accessed from [The Statistical Data Portal](#). Holiday/Leisure tourists constituted 26.4 percent (312,030) of all tourists, followed by those In-Transit at 26.1 percent (309,058) and those Visiting Friends & Relatives at 22.6 percent (266,910) respectively.

1.0 Visitor Arrivals

In 2023, Botswana received a total of 1,183,432 international visitors (tourists). The majority of these visitors, 77.2 percent (913, 893) reside in the SADC region. [Appendix 8](#) shows that most tourists came from South Africa 33.3 percent (394, 090), Zimbabwe 22.3 percent (263, 697) and Zambia at 10.8 percent (128, 346). These three countries combined, accounted for 66.4 percent (786, 133) of the total number of tourists.


1.1 Port of Entry

[Appendix 1](#) shows the number of tourists per border post. Most tourists entered through Kazungula Bridge Border, 142,042 (12.0 percent), followed by Tlokweng Border Post, which recorded 139,895 (11.8 percent). The busiest airport was Sir Seretse Khama International Airport, having received 4.5 percent (53,641) of tourist arrivals.

1.2 Type of Visitor

[Figure 1](#) presents the percentage distribution of visitors by sex and type of visit. Males accounted for 65.2 percent of total overnight tourists. While females represented 34.8 percent of all tourists. A similar pattern can be observed for same-day visitors, the sex ratio was 53.3 percent male to 46.7 percent female of the total same day tourists.


Figure 1: Percentage Distribution of Tourists by Type and Sex – 2023



1.3 Purpose of Visit

[Figure 2](#) and [Appendix 5](#) illustrate the distribution of tourists by their purpose of visit. The majority of the tourists, representing 26.4 percent (312, 030) were Holiday/Leisure visitors. They were followed by those In Transit at 26.1 percent (309,058) and those Visiting Friends and Relatives at 22.6 percent (266,910). The least number of tourists, at 7.2 percent (85,134), came for 'Other' purposes, which include shopping, religious, sports, and medical reasons. [Appendix 5](#) shows that December had the highest number of tourists at 10.7 percent (126,588), followed by August at 9.8 percent (116,113). The lowest number of tourists was recorded in February, at 5.6 percent (66,269).

1.3.1 Sex Distribution

The sex distribution in **Table 1** reveals that more males visited Botswana than females in 2023. Male tourists accounted for 64.1 percent (758,992) of the visitors compared to 35.9 percent (424,440) for female tourists. The disparity is also reflected in the purpose of visit by sex, as illustrated in **Figure 3**. Among the In-Transit tourists, the ratio was 79.5 (245,629) males to 20.5 percent (63,429) females, while for Holiday/Leisure tourists, the ratio was 51.2 percent (159,860) to 48.8 percent (152,170) females.



1.3.2 Length of Stay

Table 2 and **Figure 4** present the length of stay for tourists. The majority of tourists, at 29.6 percent (350,136) stayed four to seven (4-7) days followed by those who stayed for one to three (1-3) days, representing 26.4 percent (311,987).

Tourists who came for Holiday/Leisure mostly stayed 8-14 days, accounting for 33.2 percent (103,503) of Holiday/Leisure tourists. Those whose purpose was for Visiting Friends and Relatives mostly stayed for more than 21 days, at 29.0 percent (77,301) of tourists in that category. Tourists with “Other” purposes of visit mainly stayed for less than a day, at 47.0 percent (40,010), while those who came for business predominantly stayed for four to seven (4-7) days, constituting 37.9 percent (79,710) of Business tourists.



Figure 4: Percentage Distribution of Tourists by Purpose of Visit and Length of Stay – 2023





1.3.3 Age Group

Figure 5 and **Appendix 4**, present the distribution of tourists by age group. Majority of tourists were in the middle ages of 35-44 years, representing 27.9 percent (329,683) of total tourists. The age group 45-54 accounted for 20.5 percent (242,080) of the tourists, followed by those aged 25-34 at 19.1 percent (225,652). Those aged 15 years and below were the lowest accounting for 4.1 percent (47,971) of all tourists.

1.4 Key Overseas Countries

In 2023, tourists residing in the United States of America formed the majority of overseas tourists visiting the country. **Table 3** indicates that United States of America contributed 31.5 percent (62,386) to the Top Ten Overseas Countries, followed by Germany at 20.6 percent (40,856) and the United Kingdom at 12.8 percent (25,357). Spain with 3.4 percent (6,680), completes the list of the top ten countries of residence for overseas tourists. Most of these Top Ten Overseas tourists visited mainly for Holiday/Leisure purposes. Overall this category of tourists accounted for 86.5 percent (171,578) of the 198,258 tourists from these top ten overseas countries. The second most common purpose of visit was In-Transit, at 6.3 percent (12,426). Detailed analysis of tourists by country and continent of residence can be found in [Appendix 6](#).

1.5 Key African Countries

Table 4 presents tourists residing in the Top Ten African Countries by purpose of visit. These countries accounted for 77.4 percent (915,550) of the total tourists. South Africa is the largest contributor, making up 43.0 percent (394,090) of total tourists from these top ten African countries. Zimbabwe accounted for 28.8 percent (263,697), followed by Zambia at 14.0 percent (128,346).

Tourists from South Africa came mainly to visit friends and relatives, followed by those who came for business purposes and Holiday/leisure tourists respectively. Tourists from Zimbabwe were mainly In-Transit, accounting for 36.7 percent (96,715) of total tourists coming from this country. Tourists from Zambia, Namibia, Malawi and Tanzania were mostly transiting to another country, while those from Lesotho, Eswatini, Kenya, and Mozambique visited mostly for business purposes.

1.6 Country and Region of Residence

Table 5, shows that the majority of the tourists resided in the African continent, contributing 78.3 percent (926,400) of total tourists in 2023. The SADC Sub Region accounted for the most with 77.2 (913,893), while 1.1 percent (12,507) came from the Rest of Africa. European residents made up 11.9 percent (141,367) followed by America with 6.4 percent (75,330) of total tourists into the country. The least number of tourists were of unknown origin at 0.3 percent (3,390).

2.0 Technical Notes

This section provides information on the data sources, methodology, and definitions of terms used in producing tourism statistics. It aims to help users understand how the data is sourced, how the report is processed and compiled, and what the various terms used in the report mean.

2.1 Data Sources and Methodology

The data used in the production of this report is sourced from administrative records of the Department of Immigration and Citizenship.

International tourist data is collected using Arrival forms completed by non-citizens at designated ports of entries (Land Borders and Airports). The form gathers data on the traveler's personal characteristics, such as sex, age, country of nationality, country of residence and purpose of entry. By default, data is also collected on the month of travel, mode of transport and port of entry.

The results and analysis in this report adheres to the guidelines, definitions and classifications recommended by the United Nations World Tourism Organization (UNWTO) and the United Nations Statistical Commission (UNSC). This publication is produced in accordance with internationally accepted statistical standards and guidelines.

2.2 Glossary

Overseas – All countries and territories outside the continent of Africa

Visitor - Refers to any person travelling to a place other than that of his/her usual environment for less than twelve consecutive months and whose main purpose of the trip is other than the exercise of an activity remunerated from the place visited.

Tourist (Overnight) – An international visitor who stays at least one night in a collective or private accommodation in the country visited.

Same-day visitor – An international visitor who does not spend the night in either a collective or private accommodation in the country visited.

Non-resident – Refers to a foreigner (excluding resident) entering or departing the country.
