PREFACE

Statistics Botswana is releasing the second quarterly stats brief for Tourism Statistics. This Quarter 2, 2022 Stats Brief gives a summary of international visitors entering the country during this quarter. The report gives the total number of arrivals but the discussion will be centred on tourist arrivals. The annual report will give detailed information on arrivals and departures as well as tourist arrivals for the entire year. During this quarter, all Botswana border posts were in operation after the normalisation of operations in the aftermath of the Covid-19 pandemic.

The statistics contained therein include the arrival of non-citizens by country of residence and other key characteristics. These statistics are compiled from electronic and manual embarkation records completed at gazetted points of entry into the country and cover all ports of entry as well as airports.

The country received a total of 248,946 international visitors (tourists) during the second quarter of 2022. These represented 88.2 percent of total non-citizen arrivals (282,220) the bulk of whom emanated from the SADC sub-region. South Africa contributed 79,410, representing 37.8 percent of overall tourists from SADC countries. For purpose of visit, In-Transit tourists represented the highest proportion of tourists, at 47.6 percent (99,986) followed by Business tourists at 19.9 percent (41,791), while Visiting Friends and Relatives tourists accounted for 15.8 percent (33,251) of all the tourist arrivals.



1.0 Total Arrivals


This section deals with all international arrivals, including tourists and returning residents but excludes Botswana citizens, for Quarter 2, 2022. **Appendix 12** and **13** show that the country received 282,220 arrivals, with April recording a slightly higher percentage of arrivals at 33.8 percent (95,390), while May and June recorded 33.5 percent (94, 487) and 32.7 percent (92, 343) respectively.

Appendix 12 presents total International arrivals by Purpose of Entry. It shows that most arrivals were those In-Transit at 37.3 percent (105,391), followed by those who came for Business at 16.4 percent (45,442). Those who came for Holiday/Leisure accounted for 15.5 percent (43,764), while those who came to Visit Friends and Relatives represented 12.9 percent (36,402) of total arrivals.

1.1 Port of Entry

Figure 1 and **Appendix 2**, show the number of arrivals per border post. Most arrivals came by road using Martin's Drift Border Post, 41,434 (14.7 percent), followed by Tlokweng Border Post, having recorded 40,443 arrivals (14.3 percent). The busiest airport was Sir Seretse Khama International Airport, having received 13,321 arrivals (4.7 percent).

2.0 Visitor Arrivals


In the second quarter of 2022, the country recorded a total of 282,220 non-citizen arrivals, 88.2 percent (248,946) of these were international visitors (tourists), with the remaining 11.8 percent (33,274) being returning residents. The majority of the visitor arrivals originated from the SADC region. **Appendix 11** shows that most tourists came from South Africa, Zimbabwe and Zambia. These three countries together, accounted for 70.3 percent (175,025) of all tourists, at 31.9 percent (79,410), 23.4 percent (58,302) and 15.0 percent (37,313) respectively.

2.1 Purpose of Visit

Figure 2 and **Appendix 3** show the distribution of tourists by Purpose of Visit. Tourists came into the country for different reasons and this sub-section gives the associated information. Most of the tourists were In-Transit visitors, representing 42.3 percent (105,331) of all tourists. These were followed by those who came for Business at 18.1 percent (45,150) and Holiday/Leisure at 17.6 percent (43,730). The least number was for those who came for 'Other' purposes, making up 7.4 percent (18,504) of total tourists, up 3.5 percent from 6,099 recorded in the first quarter. Other purposes here, specifically combine shopping, religious, sports and medical reasons.

Appendix 3 further shows that June recorded a slightly higher number of tourists, 84,069 (33.8 percent), followed by April at 83,726 (33.6 percent). The least number of tourists was recorded in May at 81,151 (32.6 percent).

2.1.1 Sex Distribution


The sex distribution in **Table 1** and **Figure 3** shows that more males visited Botswana compared to females during this quarter. Male tourists contributed 70.8 percent (176,270) of all visitors compared to 29.2 percent (72,676) for female tourists. This disparity is also observed in the purpose of visits by sex. Business and In-Transit tourists accounted for 78.4 percent (35,379) males to 21.6 percent (9,771) and 83.3 percent (87,735) males to 16.7 percent (17,596) females respectively. Interestingly, despite the glaring disparities between male and female proportions in different purpose of visit, the proportion of female visitors arriving for shopping, religious activities, medical reasons, etc. were almost of the same ratio (48:52) as that of male visitors arriving for the same purpose.

2.1.2 Length of Stay

Table 2 and **Figure 4**, present the length of stay of tourists during this quarter. The majority of tourists spent four to seven (4-7) days at 35.8 percent (89,062) followed by those who spent one to three (1-3) days, accounting for 29.8 percent (74,118).


Holiday/Leisure tourists accounted for the bulk of visitors who spent more than 21 days at 49.4 percent (13,095), followed by those Visiting Friends & Relatives and those who were In Transit at 36.1 percent (10,798) and 10.6 percent (3,178) respectively.

Those who were In-Transit and those who came for Business purposes mainly spent four to seven (4-7) days as can be observed in **Table 2**. Those who came for Holiday/Leisure mostly spent more than 21 days, while those who came for Visiting Friends and Relatives mainly spent 4-7 days. Tourists who came for "Other" purposes mainly stayed for one to three (1-3) days.

Figure 4: Percentage Distribution of Tourists by Purpose of Visit and Length of Stay – Q2 2022




2.1.3 Age group

Figure 5 and **Appendix 7**, present the distribution of tourists by age group. During this quarter, the majority of tourists were in the middle ages of 35-44 years, representing 32.0 percent (79,754) of total tourist arrivals (248,946).

The age group 45-54 accounted for 22.0 percent (54,702) of total Tourists, followed by those aged 25-34 years at 20.0 percent (49, 883).

2.2 Key Overseas Countries

The United States of America was the major source of tourists from overseas (**Table 3**). The country supplied 37.6 percent (11,562) of all top ten overseas tourists, followed by Germany and the United Kingdom at 19.1 percent (5,858) and 12.9 percent (3,970) in that order. Australia occupied the last spot with 2.6 percent (811).

As can be observed in **Table 3**, the top ten overseas countries had Holiday/Leisure as the main purpose of visit. Overall, the category represented 73.2 percent (22,501) of the 30,720 tourists from the Top Ten Overseas countries. In Transit is the second most popular purpose of entry at 12.6 percent (3,876).

Appendix 9 shows a detailed analysis of tourists by country and continent of residence.

2.3 Key African Countries

Table 4, based on **Appendix 9** shows tourists by country of residence and purpose of visit from the key African countries. All of these countries are in the SADC sub-region and they accounted for 84.3 percent (209,937) of the total tourists. South Africa comes first with 37.8 percent (79,410). Zimbabwe had the second largest number of tourists amongst the top ten African countries, at 27.8 percent (58,302) followed by Zambia with 17.2 percent (37,313). Notably, visitors from Zimbabwe whose purpose of visit is described as shopping, religious activities, medical reasons, etc. constitutes almost two-thirds of all visitors from the top 10 African countries arriving in Botswana under that category of visit. Meanwhile, visitors from South Africa mainly dominate in the business (three-in-four) and holiday/Leisure (three-in-five) categories among all visitors from the top 10 African countries that arrived in Botswana. There were two countries that individually contributed less than one percent of tourists. These were Mozambique at 0.4 percent (902) and Angola with 0.2 percent (339) of tourists from the top 10 African countries.

2.4 Country and Region of Residence

Table 5 shows that most of the source countries are from the African continent. The continent provided 85.0 percent (211,524) of tourists. The SADC Sub Region accounted for the majority with 84.5 (210,249) while 0.5 (1, 275) came from the Rest of Africa. Europe accounted for 7.2 percent (17,870) of total tourists. The least number of tourists was from the Middle East at 0.1 percent (246).

3.0 Technical Notes

This section presents data sources, methodology and definition of terms used in production of tourism statistics. This is meant to enable the users to interpret the statistics carried in this stats brief with understanding of how the data is sourced, how processing and compilation of the report is done and what the various terms used in the report mean.

3.1 Data Source and Methodology

The data used in the production of this report is sourced from administrative records of the Department of Immigration and Citizenship.

International tourist data used in this publication was collected using Arrival forms that were completed by non-citizens at gazetted ports of entry (Land Borders and Airports). Each form asks questions on personal characteristics of the traveller which include among others, sex, age, country of nationality, country of residence and purpose of entry. By default data is also collected on the month of travel, mode of transport and point of entry.

The results and analysis presented in the report follow the guidelines, definitions and classifications recommended by the United Nations World Tourism Organization (UNWTO) and the United Nations Statistical Commission (UNSC). This publication is produced in line with international accepted statistical standards and guidelines.

3.2 Glossary

Traveller- An individual who moves between different geographic locations (in this case country) for any purpose and any duration.

Overseas – All countries and territories outside the continent of Africa

Visitor - Refers to any person travelling to a place other than that of his/her usual environment for less than twelve consecutive months and whose main purpose of the trip is other than the exercise of an activity remunerated from the place visited.

Tourist (Overnight) – An international visitor who stays at least one night in a collective or private accommodation in the country visited.

Same-day visitor– An international visitor who does not spend the night in either a collective or private accommodation in the country visited.

Excursionist – A same-day visitor whose trip does not include an overnight stay (usually for leisure).

Resident – Refers to a non-citizen residing in Botswana on a permanent or temporary basis.

Country of Nationality – A country where citizenship is held.

Non-resident – Refers to a foreigner (excluding resident) entering or departing the country.
