PREFACE

This stats brief presents a summary on characteristics of expatriates who held valid work permits as at the end of December 2021.

The brief is produced through a collaborative process with the Department of Labour and Social Security who issue work permits. Copies of the approved work permits are forwarded to Statistics Botswana for capture and analysis.

Information on work permit holders gives an indication of the posts which are occupied by foreigners for monitoring progress in localization. Presentation of statistics on work permit holders by occupation and industry gives an indication of jobs currently held by non-citizens which informs on the skills and sectors where expatriate recruitment continues to be needed. The information is also useful to researchers, planners and policy makers in the country.

The results presented in this brief show a decrease in work permit holders from 3,779 in September 2021 to 3,409 in December 2021, a decrease of 9.8 percent. The Agricultural sector continues to record the majority of the work permit holders with 25.2 percent followed by Construction with 15.1 percent. Work permit holders by age group showed that overall, the number of persons aged 40-44 was leading with 17.3 percent followed by age groups 45-49 and 35-39 recording 16.9 percent and 16.1 percent respectfully.

1.0 INTRODUCTION

Work permits represent an authorization issued by the Department of Labour and Social Security allowing nationals of other countries to work legally in the country. This depicts both newly issued and renewed work permits as at December 2021. Entries on the work permit shows the reasons for issuing the permits. The main reasons for issuing such permits are employment, education, family, and other reasons. The analysis of permits in this brief is confined only to work permits, drawn from National administrative registers and databases.

The Department of Labour and Social Security issues work-permits, and copies of such issued workpermits are forwarded to Statistics Botswana to be analyzed. Although all work permit forms received by Statistics Botswana for a specific quarter are processed and entered into the data base, others arrive after the publication of the stats brief, and are thus captured for analysis for the subsequent publication.

The profile of work permit holders at country level reflects the specific skills which may be in short supply among the nationals. In addition, it may show the prevailing economic and employment opportunities which attract foreigners into the country.

Six graphical presentations are given; Figures 1 & 2 presents work permit holders by Nationality, Figures 3 & 4 depicting work permit holders by industry and occupation respectively. Figures 5 & 6 illustrate the trend of total work permit holders and employee work permit holders respectively. More detailed information is presented in the tables.


2.0 TOTAL WORK PERMIT HOLDERS


Table 1.1a provides information on the total number of work permit holders. There were 3,409 valid work permit holders as of end of December 2021. Employed persons accounted for 80.8 percent (2,754) while Self- employed persons accounted for 19.2 percent (655). Overall, there were more male than female work permit holders at 75.0 percent and 25.0 percent, respectively (See Table 1.1a).

Employee work permit holders consist of those holding new work permits and those whose work permits have been renewed. As it can be observed in **Table 1.4a**, there were 2,205 new employee work permit holders while 549 held renewed permits. In both categories males comprised of a higher proportion of work permit holders. For the new work permit holders, males accounted for 60.2 percent of the total employee work permit holders and 19.8 percent for females while for the renewed ones males accounted for 14.8 percent and females 5.2 percent.

Table 1.7 shows quarterly work permit holders by industry and sex from the first quarter of 2021 to the fourth quarter of 2021. The data shows a general decline in the total work permit holders over the period. Between March 2021 and June 2021, total work permits holders decreased by 65 persons, from 3,523 in March 2021 to 3,458 in June 2021, a decrease of 1.8 percent. The total work permit holders increased by 321 persons between June 2021 (3,458) and September 2021 (3,779), an increase of 9.3 percent. Total work permit holders decreased by 370 persons from (3,779) September 2021 to (3,409) December 2021, a decrease of 9.8 percent. From the first quarter of 2021 (March 2021) to the fourth quarter of 2021 (December 2021), total work permit holders decreased by 114 persons, a decline of 3.2 percent.

Figure 1 and **Table 1.1b** indicates that Zimbabweans continues to have the highest proportion of work permit compared to other nationals accounting for 44.1 percent (1,504), followed by South Africans at 13.4 percent (458).






3.0 WORK PERMIT HOLDERS BY AGE GROUP

The age distribution of work permit holders showed that the highest number was recorded in the 40-44 age group at 17.3 percent, followed by the 45-49 and 35-39 years age groups recording 16.9 and 16.1 percent respectively. For the self-employed category, age group 45-49 had the largest share with 136 permit holders (20.8 percent) followed by the 50-54 age group with 101 permit holders (15.4 percent). In the employee work permit holders category, the 40-44 age group stood at 508 permit holders (18.4 percent) followed by the age group 35-39 with 483 work permit holders (17.5 percent), See Table 1.2a & 1.2b. There were 771 work permit holders in the youth age group (15-35) which accounted for 22.6 percent of the total work permit holders.


4.0 WORK PERMIT HOLDERS BY INDUSTRY

Table 1.3b & **Figure 3** present the distribution of Employee and Self-Employed work permit holders by Industry. The highest proportion of work permit holders were registered for Agriculture with 25.2 percent, followed by Construction with 15.1 percent and Education with 13.8 percent of work permit holders. Agriculture also recorded the highest proportion of the employee work permit holders' category with 29.2 percent, followed by Education with 16.8 percent. For the self-employed work permit holders' category, Wholesale & Retail Trade was above other industries, recording 26.9 percent of work permit holders, followed by Construction and Real Estate at 13.9 percent and 13.1 percent respectively.



5.0 WORK PERMIT HOLDERS BY OCCUPATION

Employee work permit holders (New and Renewed) by Occupation is shown in **Figure 4**, and **Tables 1.4a and 1.4b**. The tables show that elementary occupations recorded the highest proportion of work permit holders of 27.9 percent (769 persons) followed by Professionals with 701 persons (25.5 percent). Furthermore, the majority of new permit holders were recorded in the Elementary occupations category, accounting for about 30.2 percent (665 persons) of all new work permit holders followed by professionals with 24.9 percent (548).




6.0 EMPLOYEE WORK PERMIT HOLDERS BY TRAINING

The distribution of employee work permit holders by training and sex is presented in **Table 1.5a** and **1.5b**. It can be observed from the tables that the proportion of employee work permit holders who had No Training accounted for more than one third of all employee work permit holders at 43.2 percent (1,190 persons) followed by Degree holders at 32.3 percent (889). Diploma holders accounted for 16.3 percent (450 persons) which is less than a quarter of the employee permits, while Certificate holders contributed 8.2 percent (225 persons) of employee work permit holders.

Table 1.6a & **1.6b** shows that, the largest number of employee work permit holders are trained for Engineering and Allied programs 306 (11.1 percent) followed by those trained for Medicine and Health related programs with 212 persons (7.7 percent) and Education Training programs with 186 persons (6.8 percent). Mass Communication & Documentation recorded the lowest share of 5 persons (0.2 percent).

7.0 TREND OF TOTAL WORK PERMIT HOLDERS

Table 1.8 and **figure 5** below shows a trends in work permit holders from the year 2012 to 2021. There was a significant decrease in work permit holders between the year 2012 and 2016, from 11,062 to 5,293, representing a plunge of 52.3 percent. Between the year 2016 and 2021 the number of work permit holders further decreased from 5,293 to 3,409, a decline of 35.6 percent.

8. TREND OF EMPLOYEE WORK PERMIT HOLDERS

Table 1.9 and **figure 6** below show a trend in total employee work permit holders from the year 2012 to 2021. The trend shows that between the year 2012 and 2014 there was a significant decrease in employee work permit holders, from 6,897 to 4,092, a decrease of 40.7 percent. Between the year 2014 and 2017 the number of employee work permit holders increased from 4,092 to 5,045, an upsurge of 23.3 percent while between the years 2017 and 2021 the number of work permit holders further declined from 5,045 in 2017 to 2,754 in 2021 a decrease of 45.4 percent.
